CONTACT DETAILS IN THE EVENT OF AN EMERGENCY:-

- 1: I.....the owner of.....agree that I am solely responsible for the care of my horse / pony including feeding, watering, exercise, vet fees, care and attention, shoeing and worming, Except otherwise written.....
- 2: Stainsby Grange has the right to call the vet or farrier to attend the horse when in our opinion is necessary:
 - 2b Stainsby Grange will try to contact the owner first in the case of emergency. However, we are free to make decisions in the horse owners absence, based on the professionals advise (e.g.:- surgery or humane destruction)
- 3: Yours vets name and telephone number.....
- 4: We require you to be adequately insured for 1/3 part liability and risks associated with straying, minimum of£500,000
- 5: Any tack, equipment, transport left on premises is left at entirely the owner's risk. We shall not be liable to you for any loss, injury, illness or death to your horse.
- 6: Livery Fees are due on a weekly basis
- 6B: The livery contract may be terminated by yourselves by 14 days written notice
- 6C: The livery contract may be terminated by ourselves with immediate effect.
- 6D: Stainsby Grange holds the right to sell the horse, tack or transport in order to meet unpaid livery bills
- 7: Any order given by a member of staff must be carried out
- 8: Any incident or accident must be reported to a member of staff so it can be recorded. First Aid box is in the office
- 9: The Yard closes at 8pm unless otherwise written. Any one wishing to stay later on any one night must make prior arrangements.
- 10: Stables must be mucked out, de cobwebbed and painted by yourselves on a yearly basis
- 11: For health and safety reasons tools and barrows must be put away after use.
- 12: Feed must be kept at home and not in lockers
- 13: Any person/ horse travelling in the wagon at any times does so at their own risk. No responsibility will be taken by SGRC or proprietors
- 14: Please be aware of fire exits and know what to do in case of fire:-
- 15: You must:-
 - A: Keep all your personal property in the yard tidy
 - B: Let us know if there is damage to fencing, stable etc., so we can repair it.
 - C: Keep the yard tidy leaving no litter
 - D: If you are leaving your horse/pony in the care of others we must know about it in writing with their appropriate details and written consent from you

E: If letting someone else ride your horse/pony please make sure (if a minor their parents know) as they will not be covered by your insurance and that you will be solely in charge.

Livery Agreement for _____ Cont..

- 16: We strongly suggest that you take out personnel accident cover for riding and you must always ride in correct footwear, hats to current BS Standard) fastened and appropriate wear in the dark.
- 17: Stables remain the property of Stainsby Grange
- 18: Droppings must be picked up the field on a weekly basis and Ragwort if any
- 19: You must worm your horse every 6 – 8 weeks.
- 20: You are responsibility for your own horse's passport however a copy must be attached to this form
- 21: You must not use the jumps in the main arena unless you are under the direct supervision of an adult who is Experienced in their use and familiar with the striding for individual horses/ponies.
- 22: Any jump that is broken must be reported to us and paid for.
- 23 a: Current standard of Hard hats MUST be worn when catching, turning out, lunging and riding. If you don't carry out this rule its at your Own risk.
- 23b: Turn horses head towards the gate before you let it go.
- 23 c: Always close the gate at the road
- 23 d: No litter to be left in the field
- 23 e: Head Collars and leadreins must be used when catching and turning out.
- 23 f: No one who hasn't signed this form is allowed to turn out your horse or go in the field. You are responsible for your horse and other peoples safety.
- 24: No use of walker unless you have had prior training and must be cleaned out immediately after use
- 25: You must let us know of Anyone LOANING or Riding your horse on a regular basis as they need to fill in appropriate forms.
- 26: Lunge pen may only be used by over 18s and is only for lunging, you must wear appropriate riding hat.
- 27: Safeguarding:- If leaving your child (U18) to look after his/her own horse you do so at entirely your own risk. We are not responsible for looking after your child or where your child goes once you have dropped them off. We ask for al children under 16 to be accompanied by an adult at all times
- 28: The owner shall ensure that no children under the age of 16 are brought onto the yard unless under the supervision of the owner at all times.
- 29: Any Livery bringing POMS onto the yard must keep them locked up securely.
- 30: Any Cleaning fluids must be locked up securely.
- 31: If going on holiday you must hand your horses passport into the HOUSE
- 32: Horses must vaccinated against Flu on a yearly basis after the primary course is done

- 33. All our policies inc Data Protection, risk assessments safe guarding, cctv and anti bullying are available for access. Also some are on our website www.stainsbygrange.co.uk
- 34: The outdoor is available sometimes, this will be advertised on either the notice board or by whatsapp. Strictly no jumping in the outdoor unless in a lesson or show.
